This Privacy Policy describes Our policies and procedures on the collection, use and disclosure of Your information when You use the Service and tells You about Your privacy rights and how the law protects You.

We use Your Personal data to provide and improve the Service. By using the Service, You agree to the collection and use of information in accordance with this Privacy Policy. This Privacy Policy has been created with the help of the Free Privacy Policy Generator.

Interpretations and Definitions

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Privacy Policy:

Account means a unique account created for You to access our Service or parts of our Service.

Affiliate means an entity that controls, is controlled by or is under common control with a party, where "control" means ownership of 50% or more of the shares, equity interest or other securities entitled to vote for election of directors or other managing authority.

Company (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Chiarelli Milano Jewelry Inc, 8254 NW 34st, 33122 Miami.

Cookies are small files that are placed on Your computer, mobile device or any other device by a website, containing the details of Your browsing history on that website among its many uses.

Country refers to: Florida, United States

Device means any device that can access the Service such as a computer, a cellphone or a digital tablet.

Personal Data is any information that relates to an identified or identifiable individual.

Service refers to the Website.

Service Provider means any natural or legal person who processes the data on behalf of the Company. It refers to third-party companies or individuals employed by the Company to facilitate the Service, to provide the Service on behalf of the Company, to perform services related to the Service or to assist the Company in analyzing how the Service is used.

Usage Data refers to data collected automatically, either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

Use of Your Personal Data

The Company may use Personal Data for the following purposes:

- **With Your consent:** We may disclose Your personal information for any other purpose with Your consent.

Retention of Your Personal Data

The Company will retain Your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use Your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes, and enforce our legal agreements and policies.

The Company will also retain Usage Data for internal analysis purposes. Usage Data is generally retained for a shorter period of time, except when this data is used to strengthen the security or to improve the functionality of Our Service, or We are legally obligated to retain this data for longer time periods.

Transfer of Your Personal Data

Your information, including Personal Data, is processed at the Company's operating offices and in any other places where the parties involved in the processing are located. It means that this information may be transferred to — and maintained on — computers located outside of Your state, province, country or other governmental jurisdiction where the data protection laws may differ than those from Your jurisdiction.

Your consent to this Privacy Policy followed by Your submission of such information represents Your agreement to that transfer.

The Company will take all steps reasonably necessary to ensure that Your data is treated securely and in accordance with this Privacy Policy and no transfer of Your Personal Data will take place to an organization or a country unless there are adequate controls in place including the security of Your data and other personal information.

Delete Your Personal Data

You have the right to delete or request that We assist in deleting the Personal Data that We have collected about You.

Our Service may give You the ability to delete certain information about You from within the Service.

You may update, amend, or delete Your information at any time by signing in to Your Account, if you have one, and visiting the account settings section that allows you to manage Your personal information. You may also contact Us to request access to, correct, or delete any personal information that You have provided to Us.

Please note, however, that We may need to retain certain information when we have a legal obligation or lawful basis to do so.

Disclosure of Your Personal Data

Business Transactions

SUBJECT

Information pursuant to art. 13 of D. Lgs. 196/2003 and article 13 of EU Regulation n. 2016/679.

Pursuant to art. 13 of D. Lgs. 196/2003 (hereinafter "Privacy Code") and art. 13 of EU Regulation No. 2016/679 (hereinafter "GDPR 2016/679"), laying down provisions for the protection of individuals and other subjects with regard to the processing of personal data, We wish to inform you that the personal data you provide will be processed in compliance with the above mentioned legislation and the confidentiality obligations to which CHIARELLI GIOELLI SRL is bound.

DATA CONTROLLER

The Data Controller is "CHIARELLI GIOIELLI SRL" (02445590447), with registered office in 63900 Fermo (FM), Via Bergamasca 4, in the person of co-director Luigi Chiarelli Gonzaga, domiciled for office at the company headquarters.

DATA PROTECTION OFFICER

The Data Protection Officer (DPO) and Data Controller is Mr. Luigi Chiarelli Gonzaga, domiciled for office at the company's headquarters.

PURPOSE OF THE PROCESSING

The personal data you provide are necessary for the fulfillment of the law, and for the processing of information relating to the commercial purpose of the data controller.

METHODS OF PROCESSING AND STORAGE

The processing will be carried out in automated and/ or manual form, in compliance with the provisions of art. 32 of GDPR 2016/679 and Annex B of D.Lgs. 196/2003 (art. 33-36 of the Code) on security measures, by subjects specifically appointed and in compliance with the provisions of art. 29 GDPR 2016/ 679. Please note that, in compliance with the principles of lawfulness, limitation of purposes and minimisation of data, pursuant to art. 5 GDPR 2016/679, subject to your free and explicit consent expressed at the bottom of this statement, your personal data will be stored for the period of time necessary to achieve the purposes for which they are collected and processed.

SCOPE OF COMMUNICATION AND DISSEMINATION

We also inform you that the data collected will never be disseminated and will not be communicated without your explicit consent, except for the necessary communications that may involve the transfer of data to public bodies, consultants or other persons for the fulfilment of legal obligations.

TRANSFER OF PERSONAL DATA

Your data will not be transferred either to Member States of the European Union or to third countries outside the European Union.

SPECIAL CATEGORIES OF PERSONAL DATA

Pursuant to Articles 26 and 27 of Legislative Decree No. 196/2003 and Articles 9 and 10 of the EU Regulation No. 2016/679, you may confer data to the data controller that can be qualified as "particular categories of personal data" and that is those data that reveal "racial or ethnic origin, political opinions, religious or philosophical beliefs, or union membership, as well as genetic data, biometric data intended to uniquely identify a natural person, data relating to the health or sexual life or sexual orientation of the person".

These categories of data may be processed only after your free and explicit consent, expressed in written form at the bottom of this statement.

EXISTENCE OF AUTOMATED DECISION-MAKING, INCLUDING PROFILING

"CHIARELLI GIOIELLI SRL" does not adopt any automated decision-making process, including profiling, referred to in Article 22, paragraphs 1 and 4, of EU Regulation No. 679/2016.

RIGHTS OF THE DATA SUBJECT

At any time, you may exercise, pursuant to art. 7 of Legislative Decree no. 196/2003 and articles 15 to 22 of EU Regulation no. 2016/679, the right to:

- a) request confirmation of the existence or otherwise of your personal data;
- b) obtain information about the purposes of the processing, the categories of personal data, the recipients or categories of recipients to whom the personal data have been or will be communicated and, where possible, the retention period;
- c) obtain rectification and deletion of data;
- d) obtain the restriction of processing;
- e) obtain the portability of the data, that is, receive them from a data controller, in a structured, commonly used and machine-readable format, and transmit them to another data controller without hindrance;
- f) oppose the processing at any time and also in the case of processing for direct marketing purposes;
- g) oppose an automated decision-making process for people fisiche, including profiling.
- h) ask the controller for access to and rectification or erasure of the personal data or limitation of the processing of personal data concerning the controller or to object to the processing thereof, in addition to the right to data portability;
- i) withdraw your consent at any time without prejudice to the lawfulness of the processing based on the consent given before the withdrawal;
- j) lodge a complaint with a supervisory authority.
